Besides their duties as board officers, they were all very committed to the club and were an very intragual part of making our club great. They will certainly be missed. At the same meeting we welcomed Meghan Lupotsky, Kathy Granahan and Sarah Smith. We thank them for volunteering to serve on the board.

As many of the board members get closer to moving on from membership of the club, we encourage newer members to get involved on the board at any level. Membership

Our membership is certainly going through a transition period. We have had a larger number of long time members resign than new members join the club in the past few seasons. I have been around long enough to been through this before only to see our club grow through it. We have 188 bonded members to date with a good number of 2014 trial members joining as full members. Membership is the life blood of the club and drives our financial budget. We need to continue to grow and attract new members and our best form of advertisement is you our members. I would guess that most current members were invited to the club by a friend or neighbor. Please invite your friends or neighbors to the club for a visit and encourage them to join as either a trial member or bonded member.

As of this season the board decided to allow all new members wishing to join as bonded members the opportunity to break out their bond payment over 2 years. The new member must pay the second year bond payment in order to get their bond. If they do not pay the second payment they will forfeit the first 250.00 payment. By doing this we hope to attract



new bonded members and keep our upfront pricing competitive.

Finances

The board is happy to announce that there will not be a dues increase this year. Through careful financial planning and budgeting we continue to operate in the black despite our lower membership numbers. Our goal is to be fiscally responsible to our membership.

Invoices and registration forms will be sent the week of March 23rd. The registration forms will be pre-filled. Please review and correct any information and return the registration along with your payment.

Dues can be paid on line via the website using Pay-Pal. There is a small charge to use this service, but it is a great way to earn extra reward points. Check it out today. **Each family must return their membership form along with the yearly dues payment by Friday May 8th to avoid paying a 25.00 late fee.**

Membership Termination

Any members wishing to not to renew their membership must contact the board in writing prior to **March 15, 2015**. Communication can be in the form of an email or letter. If we do not receive your request, by the

15th, you will be obligated to pay the dues for 2015. Failure to pay dues will result in forfeiture of your bond money.

We add members to the outlist as of the date of the notification. Bonds are paid out on a first come first served basis determined by your position on the outlist and new members joining the pool. We make every effort to pay out as many bonds as possible sometime at the end of June or early July of the next season. If all bonds are not paid out in the summer, we will take a look at our financial situation and determine if we can pay out any other bonds that year. Any bonds left over will be paid out first the next June.

We worked hard last year to get caught up on bond distribution. Some bonds were not picked up at the pool gate. If you haven't received a bond, please contact me or the membership chair via the website.
